1. The above named participant intends on participating in the 2016 Band Trip to Hawaii.
2. The APPROXIMATE total cost of the Band Trip per participant is \$2,800.00. This total includes airfare, lodging, meals and costs of planned tours.
3. The cost of the trip may go up or down by a small amount depending on the number of participants, cancellations, airfare, excursions, meals, shipping charges for instruments and uniforms, etc.
4. All money obtained by fundraising and donations can only be used by student participants.
5. I agree to accept responsibility for the remaining balance of the trip per the attached payment/deadline schedule.
6. If for any reason the above named participant cancels their participation on this trip, I understand that monies will be forfeited per the cancellation schedule attached. All written communication must be delivered to the Band Room to the attention of Mary Runyan.
7. It is also my understanding that any monies contributed towards this trip through fundraising are non-refundable.
8. Each new participant added to the trip after September 1, 2016 will be assessed a \$200.00 surcharge in addition to any vendor fees or rate increases incurred by the travel agency.
9. The Altus High School Band has the right to terminate this agreement with the above named trip participant for failure to comply with the attached payment/deadline schedule. If the funds are not submitted you may receive notification of the agreement termination. Termination will result in forfeiture of funds per the cancellation schedule attached and the above named trip participant will be excluded from participating in this trip.

10. Payment of the minimum monthly installments must be made in a timely manner in the form of cash, check, money order, or fundraising monies collected. (Fundraising money collected is for student participants only)

11. All students participating in this trip must comply with school board policies pertaining to eligibility and drug testing.

12. The band director may deny participation in this event. Denial on the basis of disciplinary action shall result in forfeiture of all deposits and fundraising.
